Make sure to keep your year-end statement and any other records in a safe place or sign up for eStatements to retrieve them online! It is fast and easy!

- 1099 forms are only sent out if your savings (Share) interest income is \$10.00 or more
- 1098 forms are only sent out for real estate loans with interest of \$600.00 or more



You will find your interest paid for 2014 on December's 2014 statement for tax reporting if you do not receive a 1098.
